### Reviews: How To Terminate Probation Early - Get Off ...

Once probation is over, the probationer is no longer required to comply with the terms of probation. If you're unsure of the details of your probation, feel free to ask your attorney or probation officer for help. Some probationers can apply for an early termination of their probation. When deciding whether or not to grant an early termination, the court will consider many factors, including the nature of the probationer's crime and his compliance with the terms of probation.

### What Happens After You Complete Probation?

Yes. Maryland law gives judges the authority to release defendants from probation early. (Generally, to be released from probation early you have to pay off your fines, complete at least half of your probation and complete all court ordered classes and treatment.)

### Can I get off of federal probation early? - Roadmap to Reentry

The only way to complete probation is to follow the rules and comply with all requirements of your criminal sentence. When you are placed on probation, you are being given a chance to remain in society, under the supervision of the court, rather than be incarcerated. You will have to comply with the terms and conditions set by your probation officer.
